IN 2020, DURING THE PANDEMIC, 146 INDIVIDUAL STUDENTS PARTICIPATED IN VIRTUAL AND IN-PERSON CLASSES FOR A TOTAL OF 1680 HOURS. MANY OF THESE STUDENTS ACHIEVED CERTIFICATIONS IN SEWING TOWARD EMPLOYMENT, OR ENTREPRENEURSHIP, WHILE OTHER STUDENTS LEARNED A NEEDED SKILL IN TODAY'S SOCIETY-SEWING.

IN 2020, THE SEWING LABS ENGAGED OVER 267 VOLUNTEERS IN 32,823 HOURS
